BEAVERHEAD COUNTY TAX APPEAL BOARD IN SESSION

In accordance with 15-15-101(6) MCA, the Beaverhead County Tax Appeal Board will be in session from July 1st through December 31st, 2026, for the business of hearing appeals of property valuations set by the Montana Department of Revenue.

Any taxpayer who disagrees with the appraised value of his or her property may file an appeal with the Beaverhead County Tax Appeal Board within 30 days of the date on the Notice of Classification and Appraisal or Notice to Change Valuation (assessment notice).

Appeal forms are available at the Beaverhead County Clerk & Recorder's Office, or at the website of the Montana Tax Appeal Board, www.mtab.mt.gov.

Any appeal must be filed with the Office of the County Clerk and Recorder.

Upon receipt of the appeal, the County Tax Appeal Board Secretary will notify the appellant and schedule a County hearing.

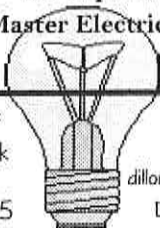

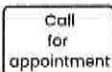

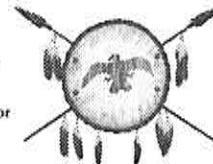

Shooting Facilities Task Force to meet May 15

The 69th Montana Legislature passed House Bill 899 (HB899), which created the Montana State Shooting Facilities and Improvements Development and Oversight Task Force. The Task Force is responsible for identifying shooting facility needs in Montana. This may include improving existing facilities or developing new ones. The Task Force will meet as often as necessary to accomplish its assignment on time.

The Montana State Shooting Facilities and Improvements Development and Oversight Task Force will meet Friday, May 15, from 8:30 a.m. to noon, at the Fish, Wildlife & Parks Region 4 office in Great Falls.

The task force will discuss preliminary information from the shooting facilities and individual shooter surveys.

The task force is responsible for identifying shooting facility needs in Montana and is tasked with developing a set of recommendations for the development, location and administrative structure of state shooting facilities and improvements. The deadline for the recommendations is June 30, 2027.

The public is invited to watch the meeting and participate in the public feedback session.



Helena District Court Dismisses Mr. Bail Inc.'s Request to Overturn Insurance Commissioner Brown's Emergency Suspension and Cease and Desist Order

A Lewis and Clark County District Court Judge has dismissed a lawsuit filed against Montana Insurance Commissioner James Brown challenging his suspension of Mr. Bail Inc.'s surety insurance producer license, as well as the license of one of its employees, Anna Yarbro. The legal filing requested District Court Judge Kathy Seeley overturn Commissioner Brown's emergency suspension order. The legal proceeding arises from a series of troubling incidents involving Mr. Bail Inc., a Virginia-based entity operating as a bail bond company in Montana. The most recent incident was the fatal shooting of Joshua Wykle at a convenience store parking lot in Missoula.

Following that shooting, Commissioner Brown – who regulates bail bond companies and bail bond agents – revoked the licenses of two of the agents involved. Due in part to the strength of the Commissioner's case, the two individuals did not challenge the revocations, which are now final.

Further, Commissioner Brown suspended the license of their employer, Mr. Bail Inc., and ordered the company to cease operating in Montana. As a consequence of the court's order of dismissal, the underlying emergency suspension order remains in place unless and until modified by further administrative or judicial action.

The now dismissed case is captioned Anna Lisa Yarbro et al. vs. Montana State Auditor, Case No. DV-25-2026-0000253-IJ, filed in the Montana First Judicial District Court, Lewis and Clark County.

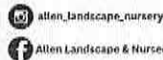

Attorney General Knudsen asks SEC to strictly scrutinize OpenAI's filings to protect investors

Montana Attorney General Austin Knudsen led a coalition of 10-state attorneys general in asking the U.S. Securities and Exchange Commission (SEC) to strictly review any filings submitted by OpenAI to protect investors and ensure fair and orderly markets ahead of the company's impending initial public offering (IPO).

In the letter sent Tuesday to SEC Chairman Paul Atkins, Attorney General Knudsen outlines his concerns with OpenAI's founder and CEO Sam Altman. Evidence suggests Altman has a history of self-dealing and serious conflicts of interest that have created significant risk for the company. Montana has investment funds directly exposed to public markets and provide retirement benefits for law enforcement officers, first responders, teachers, and other dedicated public servants. OpenAI's IPO is reportedly expected to be worth over \$1.0 trillion and the consequences of any self-dealing and conflicts of interest by Altman could create enormous financial risk and could impact state pensions and individual investors.

In the letter, Attorney General Knudsen points to reports that show significant and undisclosed or inadequately disclosed financial entanglements between Altman's personal portfolio and companies with which OpenAI has done business. Those reports also state he has leveraged his role to obtain financial support from OpenAI for his other investments.

Additionally, Attorney General Knudsen wants the SEC to ensure that Altman and other key OpenAI personnel are being fully transparent in their filings to the commission as failure to disclose conflicts of interest would constitute an example of conduct demanding scrutiny under the securities laws.
